PROGRAM ACTION ITEMS

APPROVAL OF PREVIOUS MEETING MINUTES

Motion: Approve previous meeting minutes

APPROVAL OF COMMITTEE CHARTER

- Motion: Approve to bring International Committee Charter to Council in February for approval
- Background: Each APC committee has an established charter to outline the purposes of the
 work as well as the expectations of the committee. Once approved, the charter will be
 submitted to the full council for approval with the ability to be revisited and updated
 throughout the year, as appropriate

APPROVAL OF NEW AGENCY REPRESENTATION IN CHINA

- Motion: Approve APC to begin work with committee's chosen agency
- Background: Recent findings of the McKinsey study suggests American Pecans continue to
 maintain a presence in China with a specific focus on the premium market, while strengthening
 relationships with importers and retailers. In December, APC requested proposals for Chinese
 Agencies to serve as in-market representative and received eight qualified proposals, to be
 reviewed by the International Committee.

APPROVAL OF NEW AGENCY REPRESENTATION IN GERMANY

- Motion: Approve APC to begin work with committee's chosen agency
- Background: Germany has previously been a strong market for American Pecans, however recent efforts have focused on growing awareness vs. actual purchase. As such, APC is looking for an in-market representative with strong relationships with importers and retailers to first, increase distribution of American Pecans throughout popular grocery outlets and encourage consumers to add pecans to their carts at the point of purchase. Two agencies answered the RFP.

APPROVAL OF ALLOCATED RAPP FUNDS

- Motion: Approve bringing the revised FY25 International budget to the Council in February for approval
- Background: APC was awarded an additional \$3M in RAPP funding to use toward existing
 markets such as India, UK and Germany as well as invest in new markets, including South Korea
 and Canada. Funding is available over the next five years, with no limit on how much is spent per
 year. APC will provide a breakdown of the budget recommendation in Committee.
