Schedule of Handler Reports & Assessment Due Dates REPORTING FOR THE 2019-2020 CROP YEAR

The American Pecan Council (APC) administers the Federal Marketing Order for pecans No. 986, and requires handlers to submit reports on pecans received, pecans purchased outside the United States, shipments and inventory of pecans, pecans exported by country of destination, and pecans exported for shelling and returned to the United States. REPORTING FORMS 1, 2, 3, 5 & 6 are to be delivered to the American Pecan Council no later than the tenth (10th) day of the month. Handlers will submit FORM 4 as it occurs. Year-End Inventory Report – FORM 7 is to be delivered to American Pecan Council no later than September 10, 2020. The reporting forms are provided by the Council and are to be received at the Council's office from each handler by the following deadlines.

Please note, there are revised reporting forms currently awaiting USDA OMB approval. Once approved, these reporting forms will take the six monthly reporting forms down to four with one Year-End Inventory Report. We are also developing the Handler Portal which will be an electronic reporting form platform to streamline the submission process. APC staff will be notifying industry and sending a separate handler packet with the revised forms and submission process once approved.
