SCHEDULE OF HANDLER REPORTS & ASSESSMENTS DUE For the 2021 Crop Year

The American Pecan Council (APC) administers the Federal Marketing Order for pecans No. 986, and requires handlers to submit reports on pecans received, pecans purchased outside the United States, shipments and inventory of pecans, pecans exported by country of destination, and pecans exported for shelling and returned to the United States. REPORTING FORMS 1, 2, 3 are to be delivered to the American Pecan Council no later than the tenth (10th) day of the month. If the 10th lands on a weekend, the monthly reporting forms will be due the following Monday. Handlers will submit FORM 4 on an annual basis with each company they do business with. Year-End Inventory Report – FORM 5 is to be delivered to American Pecan Council no later than September 12, 2022. All assessments are calculated on FORM 1 and are due upon submission on a monthly basis. The reporting forms are provided by the Council and are to be received at the Council’s office from each handler by the following deadlines.
